Actuaries Without Borders (AWB®) is pleased to announce an opportunity for one (1) volunteer in Sofia, Bulgaria for AWB members to facilitate a 3-days workshop with the theme of “Enterprise Risk Management” (exact dates will be agreed by volunteer and Bulgarian Actuarial Society). The workshop will provide targeting members of the Bulgarian Actuarial Society, senior executives from insurance regulatory body and companies.

The Bulgarian Actuarial Society (BAS) was first established in 1924 and re-established in 1994. BAS has about 90 members, near 50% is fully qualified.

International travel costs (restricted to lowest return economy airfare from the volunteer’s home city to Sofia) as well as lodging and incidental expenses will be reimbursed by AWB® and the Bulgarian Actuarial Society for this opportunity following the [IAA expense reimbursement policy](#).

Background Information

The Bulgarian Actuarial Society is requesting AWB® to provide 1 volunteer for a 3-days workshop with the theme of “Enterprise Risk Management” . The 3-days workshop on Enterprise Risk Management is expected to provide assistance to the members of the Bulgarian Actuarial Society, local insurance regulatory body and senior executives from companies in Bulgaria in building up risk management framework as per Insurance Core Principles (ICP) of the International Association of Insurance Supervisors (IAIS) and Solvency II framework within their industry. The course will be conducted in English.

Volunteer Qualifications

The volunteer must be a fellow actuary with preferably CERA accreditation with at least 5 years of work experience in Enterprise Risk Management. Preference will be given to volunteers who currently resides and works in Europe and must be able to present using fluent English. Preference will be given to AWB® members. If suitable AWB® members are not available, members at large would be contacted through the Actuarial Educators Network (AEN). Strong presentation and engagement skills are required for this course. Prior training experience would be a definite asset.

The Bulgarian Actuarial Society and AWB will do its best to ensure that the volunteering actuaries’ experience while in Sofia. AWB, IAA and other organizations involved in the assignment cannot and do not assume responsibility for any travel delays, illness, personal injuries or property damage.
